

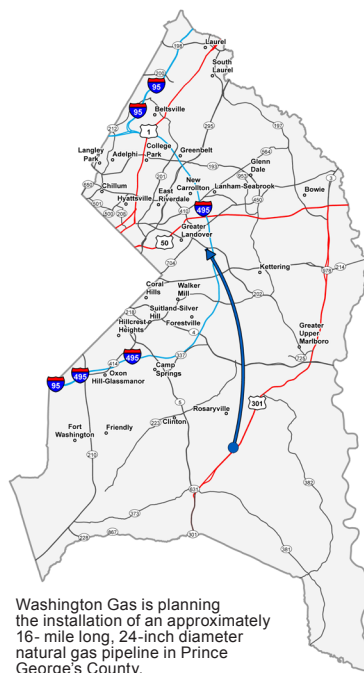
# FACT SHEET

## Prince George's County and District of Columbia Reliability and Reinforcement Project

Washington Gas, a WGL company, has provided energy solutions to the national capital region since 1848.

Clean-burning natural gas is the fuel of choice for more than nine out of 10 new homebuyers in the Washington, D.C. metropolitan area, and Washington Gas serves more than 1.1 million customers throughout the region. As the region grows, additional natural gas capacity is needed to improve reliability and reinforce the system with alternative sources during maintenance activities and periods of high-volume usage.

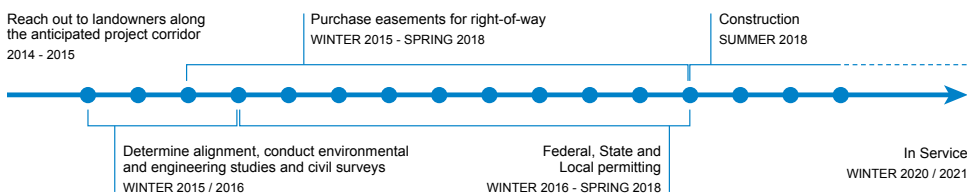
Washington Gas is constructing new infrastructure for Prince George's County and the entire region. Built mostly in public and electric utility corridors, the project paves the way for economic growth and serving more residents with clean, affordable natural gas service. The investment will include approximately 16 miles of coated steel, natural gas pipeline and regulating stations connecting two portions of Washington Gas' existing system.



Washington Gas is planning the installation of an approximately 16-mile long, 24-inch diameter natural gas pipeline in Prince George's County.

### Timeline

Washington Gas has been reaching out to affected stakeholders, including landowners, government agencies, community leaders, and others to determine a route that is constructible, environmentally responsible and addresses landowner needs. Below is a brief timeline. We value stakeholder feedback at each stage of the process and encourage input.



### Safety

Washington Gas' first priority is to provide safe and reliable natural gas service. The company monitors and inspects its distribution system at regular intervals and responds 24/7 year-round to natural gas emergencies. Washington Gas provides natural gas safety training to first responders, other emergency officials, and excavators and contractors. The company regularly provides safety information for its customers and the public. We want to keep you informed about pipeline safety and how to respond in the event of a natural gas emergency.

### Landowners

Washington Gas is reaching out to landowners that would be included in the Project work area. We are committed to treating each impacted landowner with honesty, integrity and fairness. We will continue to work closely with each landowner regarding route selection, studies, planning, construction, restoration, and operation of the pipeline. Our goal is to complete the project with as little impact to the landowners as possible.

### Key Facts

Washington Gas is developing additional natural gas infrastructure to strengthen the ability to provide safe, reliable and affordable natural gas service to the entire Washington, D.C. metropolitan region and provide for future growth and economic development.

#### LOCATION

The pipeline will connect to Washington Gas' existing system in two places—near the corner of Frank Tippet Road and U.S. 301 in the Brandywine, MD area, and a second location in Landover, MD.

#### CONSTRUCTION

The planning and permitting process is projected to be completed by the spring of 2018 and then construction could begin.

#### COMPLETION

Washington Gas is focused on achieving an in-service date of winter 2020-2021.
