### Washington Gas Project: Prince George's County and District of Columbia Reliability and Reinforcement Project ROUTE 301 (CRAIN HIGHWAY) MARLTON PLAZA NEAR FAIRHAVEN AVENUE

Dear Neighbor,

At Washington Gas, we work each and every day to safely and reliably meet the energy needs of our customers. Today, clean-burning natural gas is the fuel of choice for more than nine out of ten new homebuyers in the Washington, D.C., metropolitan area, and Washington Gas serves more than 1.1 million customers through the region. As our region continues to grow, expansion and rehabilitation of our existing infrastructure is critical to maintaining our natural gas distribution system.

As part of the Prince George's County and District of Columbia Reliability and Reinforcement Project (PGDCRRP), Washington Gas is constructing new infrastructure to serve Prince George's County and our entire service territory. This very important project is just one of many infrastructure improvements underway.

#### Construction Notice Area

Construction on Route 301 (Crain Highway) in the vicinity of Marlton Plaza, Upper Marlboro, MD 20772 in Prince Georges County, is planned to start as early as July 8, 2019 and is expected to be completed by October 2019. For this permitted section of the project, work will occur 7 days a week from 7:00 a.m. to 7:00 p.m. Construction schedules may be affected by weather and other unforeseen circumstances.

#### Road Closures and Detours

To create safe conditions for construction crews and the travelling public, one northbound lane on Route 301 (Crain Highway) will be closed with concrete barriers for the duration of this work. Access to and from Route 301 (Crain Highway) to Marlton Plaza and the surrounding area will be through Fairhaven Avenue only. See the attached map for traffic lane and access road closure locations.

Please follow traffic control signs for lane closure and reduced speed limit information. Traffic controls are managed by a traffic control plan approved by The Maryland Department of Transportation State Highway Administration.

#### What Can I Expect During Construction?

If you live near the construction area, you may hear construction noise during work hours and you can expect to see Washington Gas and contractor vehicles and equipment. For your safety, do not enter construction areas or approach vehicles or equipment. For your safety, do not enter construction areas or approach vehicles or equipment.

#### Restoration Plans

Temporary road restoration will be made immediately following the completion of this construction project. Permanent restoration will be made in compliance with the permit and occur within 45 days after all work is completed, weather permitting. Washington Gas will restore the roads and affected areas to an as-found condition.

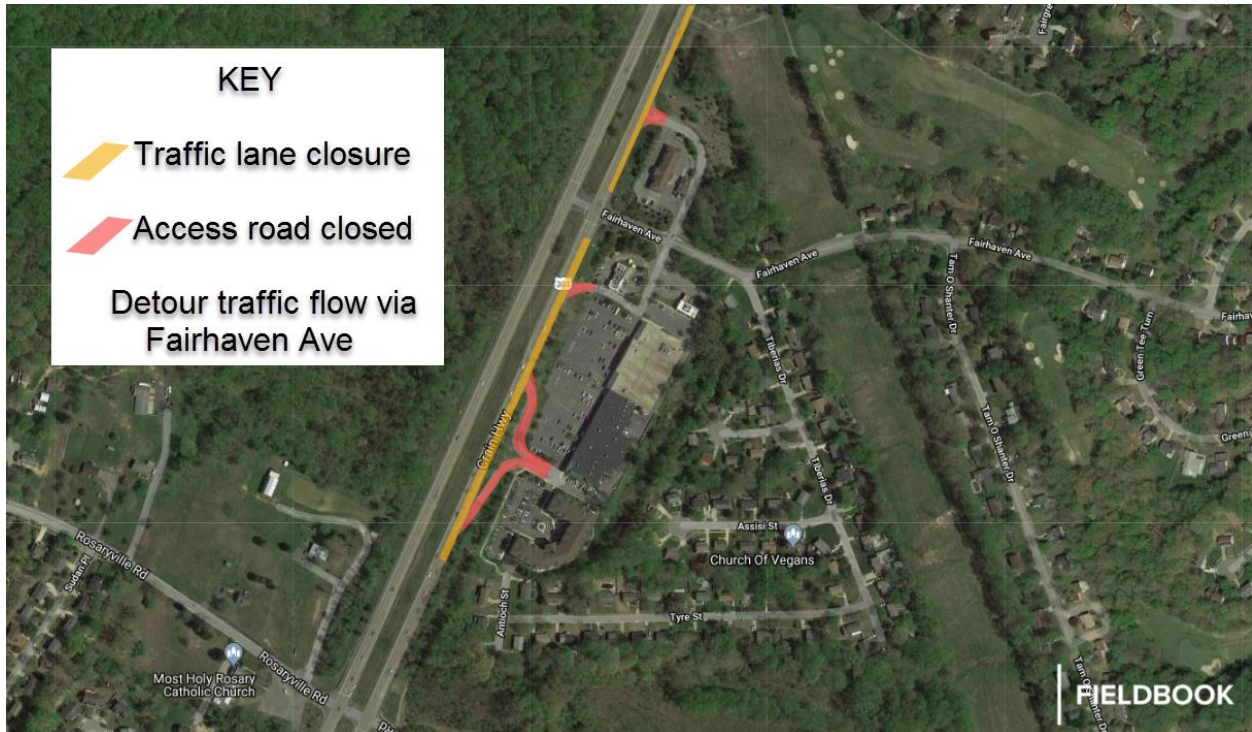
