We're reaching out to provide an update on the work occurring near your community that's part of the Washington Gas Prince George's County and District of Columbia Reliability and Reinforcement Project (PGDCRRP). A copy of the updated construction notification associated with this work is attached for your reference.

Throughout 2021, the Washington Gas and contractor project team worked safely and diligently to complete the work occurring in and near several communities along the project. The project team is proud to share that major project milestones were reached this year including installation of almost 6.5 miles of new pipeline infrastructure which included the successful completion of all four of the planned continuous-work pipe pullbacks for the project.

The project team recognizes that all construction activities present noise and other temporary disruptions for neighboring residents and continues to work to minimize disruptions and adhere to communicated plans and schedules. Due to the complexity of the work, weather conditions, and other unforeseen circumstances, the team faced several schedule changes and a few instances when we did not adhere to our communicated plan. We appreciate the open dialogue with neighboring residents as we responded to questions and addressed complaints. Our team is committed to continuing to communicate construction information with neighboring residents and address project-related questions as the work continues.

We are committed to completing the work safely and as quickly as possible. Thank you for your patience.

Dear Neighbor,

At Washington Gas, we work every day to safely and reliably meet the energy needs of our customers. Today, natural gas is the fuel of choice for more than nine out of ten new homebuyers in the Washington, D.C., metropolitan area, and Washington Gas serves more than 1.2 million customers through the region. As our region continues to grow, expansion and rehabilitation of our existing infrastructure is critical to maintaining our natural gas distribution system. As part of the Prince George's County and District of Columbia Reliability and Reinforcement Project (PGDCRRP), Washington Gas is performing work in your area. This work does not affect the natural gas service to homes or businesses.

### Construction Overview and Update – Phase 3

For this phase of the project, construction is underway within primarily private property easements extending from north of Flying Change Court in the Marlboro Ridge Community to White House Road near the intersection of Harry S. Truman Drive in Upper Marlboro, Maryland. Phase 3 construction activities are now anticipated to be complete in Spring 2022 followed by restoration. Standard work hours are Monday through Saturday, 7:00 a.m. to 7:00 p.m. Work may occur outside of standard work hours on occasion and only as needed. Construction schedules may be affected by weather and other unforeseen circumstances.

### What Can I Expect During Construction?

If you live near the construction area, you may hear construction noise during work hours, and you can expect to see Washington Gas and contractor vehicles and equipment. For your safety and the safety of construction personnel, do not cross construction barriers, enter construction areas, or approach vehicles or equipment.

Washington Gas is constructing new infrastructure in Prince George's County and the entire region.


Built mostly in public and electric utility corridors, the project paves the way for economic growth and serving more residents with clean, affordable natural gas service.
